8. NOTICES

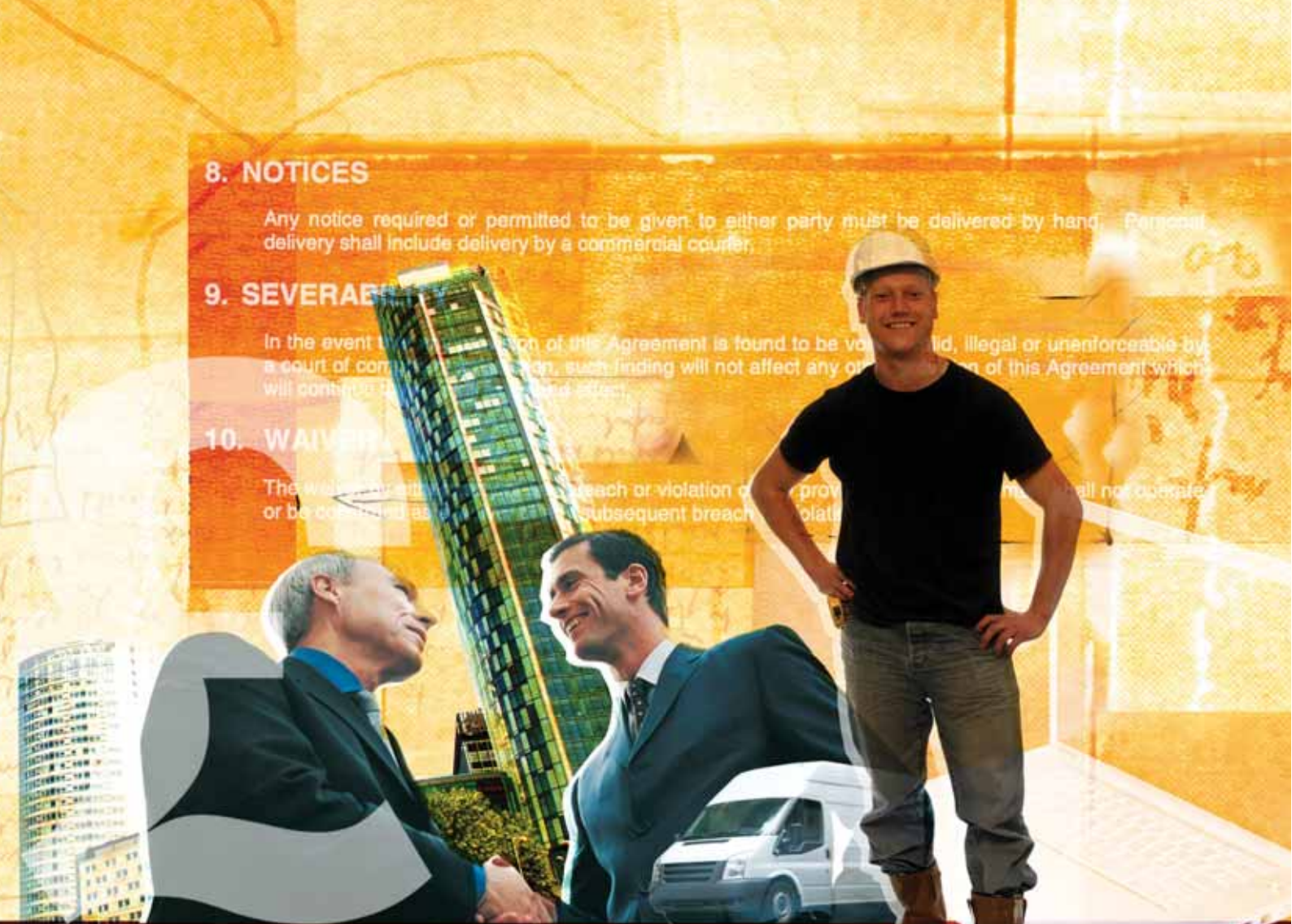
Any notice required or permitted to be given to either party must be delivered by hand. Personal delivery shall include delivery by a commercial courier.
